In May, 2009, District 1 (PBSO) had a series of business burglaries. Detective Anthony Johnson collected evidence and even made plaster casts of footprints at crime scenes. On April 18, 2009, Detective Johnson stopped two (2) suspicious vehicles, and the driver was questioned. As a result, Det. Johnson was able to recover multiple pieces of evidence

and obtained confessions of the suspect to eight burglaries. Later, he obtained a search warrant for a residence yielding \$500,000 worth of stolen items. Some 37 victims recovered their property due to his investigation.

PBSO Detectives Hermanson and Raines were assigned to the Gang Unit's "Operation Deep Six" investigation, primarily centering on Palm Beach County's most violent criminal street gang, "Top 6." Their efforts have helped to provide for all of us:

- 19 Federal Firearms arrests
- 13 Federal Narcotic arrests
- 21 Federal arrests from Title III wire intercept of Mexican Source of supply
- 32 Federal arrests from Title III wire intercept of a Local Source of supply
- 12 Racketeering arrests with the Office of Statewide prosecution
- 12 Federal Aggravated Felon Re-Entry Deportations
- 53 Arrests on numerous State charges, to include several for homicide
- The solving of several open homicide investigations

Ten Thirty Three

Sticks and Stones Have Broken Bones, but Words Have Denied Some Remedies

ore than 100 years ago, two characters in Lewis Carroll's <u>Through the Looking Glass</u> had an argument about the meaning of words:

"When *I* use a word," Humpty Dumpty said, in rather a scornful tone, "it means just what I choose it to mean – neither more nor less."

"The question is," said Alice, "whether you *can* make words mean so many things."

"The question is," said Humpty Dumpty, "which is to be master – that's all."

Unless you've been subject of a Sheriff's Office Hearing Review Board proceeding, you may be unaware of the extent to which a mere word has been the "master" of many deputies' careers. To those of you accustomed to collectively bargained grievance procedures ending in arbitration of discipline, the fact that logic and reason and centuries of jurisprudence recently have penetrated the ad hoc bodies convened in most Florida sheriffs' offices is of no consequence. To many of your brothers and sisters in green, however, what happened a few counties to the west of us this past October, is seismic.

The story begins with a deputy by the name of Kimberly Falk getting dismissed from her employment with the Lee County Sheriff's Office. Deputy Falk completed the paperwork that was put into her hands, and animated the procedure by which she could "appeal" that decision to the Lee County Sheriff's Office Civil Service Board; and that really is where this story ends, also. But as we all know about stories, between their beginnings and their endings, there are middles. Now, the middle.

At the conclusion of Deputy Falk's hearing, the Lee County Sheriff's Office Civil Service Board issued a final order by which it affirmed her dismissal. The Board affirmed the dismissal after having determined, also, that Deputy Falk failed to carry her "burden of proof" that the dismissal was without "just cause." To Falk, as to most of you familiar with such things, it seemed unfair to be burdened with proving something should not have been done. (Whatever our differences might be about the administration of justice, I'd expect all of us would take issue with a criminal defendant being required to prove he or she didn't commit the crime. Wouldn't we?).

The Board burdened Falk as it did and, likely as it had done to many other deputies before her, because she was "appealing" her termination; which made her an "appellant." On "appeals," the parties "appealing" are the ones expected to show, affirmatively, that there was something wrong about a decision. "Appellants" have the burden of proof on "appeals." As you can see, the word

assigned to what Falk was doing out in Lee County, determined the process by which it was done.

Falk's attorney filed with the circuit court a "petition" for writ of certiori. When such a petition is granted, the writ of certiori permits a court to inspect the records of an inferior authority in order to determine whether there have been any irregularities. A writ of certiori gives the circuit court very narrow jurisdiction over the lower tribunal's concluded proceedings; it is not a license for a judge to re-try the matter or, otherwise, to second-guess. In Falk's case, the writ would have permitted the circuit court to determine from the Civil Service Board's records, whether the Board's quasijudicial conduct afforded her procedural due process, "whether the essential requirements of the law were observed," and whether the Board tried to apply the correct law. Without making this middle part of our story too long, suffice it to say, the circuit court denied Falk's petition; finding that Falk's proceeding before the Board had been consistent with the essential requirements of the law. Yet, among the other things the circuit court found, was that the Lee County Sheriff's Office had the burden of proof. So, Falk's attorney filed another petition with an even higher authority; the Second District Court of Appeal.

And now, the end of the middle of our story. The 2nd DCA determined that the circuit court got it right about the burden of proof properly belonging to the Lee County Sheriff's Office, but got it wrong on which law applied. (Frankly, I got lost briefly at this point, because it seems to me the circuit court should have granted the petition even under the erroneous statute). In any event, the District Court of Appeal *granted* Deputy Falk's petition. In granting the petition, the court pointed out what Lewis Carroll's Alice might gently have explained, if she had spent only a little time in a court of law (emphasis added and citations omitted by me):

The fact that the aggrieved employee must initiate the hearing . . . or that such action is denominated as an 'appeal' does not alter the proposition that the burden of proving the basis for the termination rests with the employing agency.

The granted petition only gets Kimberly Falk a "do-over" before the Lee County Sheriff's Office Civil Service Board, which could turn out to be a trip down a rabbit hole for her. But that's the end of the story for the rest of us.

When it comes to words and the way things are done in this world, Humpty Dumpty and the 2nd DCA agree: "The question is, which is to master – that's all."

The Department is now under a new Contract and raises were not part of the plan. The members did not lose any of the other Articles that had been fought hard for in our last Contract. As was mentioned, the Salary Article is the only item to be reviewed every year until the economy improves, while the rest of the Contract remains in place for three years.

The Town of Palm Beach Shores has decided on a Blue Options health program. We have had discussion with other agencies with Blue Cross Blue Shield and had mixed reviews. Compared to the last plan issued by the Town, Blue Options is a great improvement. From the members who have had to use the plan already, the results have been positive. "Here's hopin'...."

As was posted months ago, Chief Roger Willie retired and is doing quite well. He stops in on occasion to check on us and kick up a few 'war stories' - Holy Crap.. How did we make it...?

As a follow up note, Chief Steve Kniffin has been working exceptionally hard to establish his vision for the Department. Chief Kniffin has been in the office on an average of six days a week and his efforts are noticeable. A number of "speed bumps" were thrown at him by Department and Town issues but he has maintained his course. The Chief is making new inroads with the Town Commission, and positive things are coming of his efforts. It appears that he has proven a good case for our manpower issue, and we will be getting back the road patrol position that had been cut last year due to hard economic times. We are looking at moving a well established part-timer into the opening, which will provide the extra coverage to the shifts without the excessive over-time that was created by that opening.

Lt. Steve Langevin and Detective Sergeant Kelley have picked up additional responsibilities due to the management change. They too have been pushed a little harder, but are responding to the challenges placed before them by the Chief.

The Department has been plagued with injuries (workers' compensation) and illnesses but those officers who have been asked to cover the workload are keeping the Department in order, despite some of the inconveniences it has caused. The replacement of the lost position will help us out, and again this should be credited to the Chief for his efforts. *Thank You Chief Kniffin*.

Priorities

e all have priorities in our personal and professional lives. We have all learned how to deal with things by their importance and/or seriousness. In law enforcement, we are on the "front line" as society changes and we strive to meet each challenge. We train and adapt new tactics and approaches so that we may keep ahead of the next trend. This is, of course, based on priorities and what our <u>common sense</u> tells us is important. Unfortunately, common sense is not all that common.

You can tell a lot about any organization from the priorities that are set. What is really important to an agency? What are the mission, direction, core values, and vision for the agency and its employees? What is the number one priority? All of these things will tell a vivid tale about that group.

Some have a knack for turning that priority list on its head; placing what should be on top at the bottom. By the time the priorities list is turned upside-down within a department, many unfortunate things have already occurred contributing to the inversion. Have you ever heard the motto, "Safety Last"?

There is no logical reasoning behind this type of operation. It is more easily explained by describing what is lacking than what exists. The **lack** of common sense, security, competence, and the ability to effectively prioritize and move forward means failure. Attempts to conceal this from employees can only last so long.

If the ability to prioritize, <u>really prioritize</u>, is lost, and the important things are pushed aside, the employees will undoubtedly recognize this and the agency will become the by-product of the failures. There are no longer symptoms, but the disease. We all understand priorities and how they may change quickly, but when the focus is on a set of priorities that, to all others, is backward, any attempt at progress is superficial, shallow, and completely obvious to all employees, regardless of tenure. This creates a dangerous atmosphere for all employees.

But we can find solace in the fact that this too will pass, but in the meantime remember—SAFETY FIRST!



Wilner comes between two families that have been feuding for centuries, controlling history and causing untold sorrow. He must piece together the evidence to discover the identity of the families, stop a terror attack and reunite his family while the world goes to hell around him.

PROTECT YOUR RIGHTS

The following statement should be written as the first sentences on any statement, report, or memorandum an officer is ordered to write when the officer knows or has a reasonable belief that discipline may result:

It is my understanding that this report is made for administrative, internal police department purposes only. This report is made by me after being ordered to do so by lawful supervisory officers. I have not been permitted a reasonable amount of time to confer with a PBA representative or attorney. It is my understanding that by refusing to obey an order to write this immediately, that I can be disciplined for insubordination and that the punishment for insubordination can be up to, and including, termination of employment. This report is made only pursuant to such orders and the potential punishment/discipline that can result for failure to obey that order.

National Law Enforcement Officers Memorial Fund January 2010 Officer of the Month

Officer Matthew Medeiros, Boynton Beach P.D.

ashington, DC – The National Law Enforcement Officers Memorial Fund (NLEOMF) has announced the selection of Officer Matthew Medeiros of the Boynton Beach (FL) Police Department as its Officer of the Month for January 2010.



The Medal of Valor is the highest honor a police department can give one of its officers for gallantry in action. It is only fitting that the first ever Medal of Valor presented by the Boynton Beach Police Department was awarded to Officer Matthew Medeiros.

On August 17th, 2008, a witness advised Boynton Beach police officers that a gunman,

later identified as Tarvis Wilson, had just fired a gun at someone at an intersection. Moments later the radio dispatch relayed the message that a gunman in a green Nissan Altima had attempted to shoot at a group of people nearby; however, Wilson's gun had misfired or jammed. Dispatch also relayed the fact that Wilson had just recently been released from prison. The pursuit was on.

Officer Michael Arco and Officer Medeiros spotted the suspect's green Nissan fleeing toward Interstate 95. Officer Arco attempted a traffic stop, but Wilson refused to stop and led the officers on a 37-minute pursuit through Broward County and back to Palm Beach County. Once the suspect entered the Delray Beach area, officers used "spike strips" and were able to successfully deflate the vehicle's front left tire.

The pursuing officers soon learned that the suspect's mother lived nearby and he was most likely heading to her home. Wilson led pursuing officers from several departments to within a block of his mother's house before he bailed from the vehicle and took off on foot. Sergeant Rich McNevin of the Boynton Beach Police Department attempted to cut off the suspect. He quickly exited his patrol car and began running toward the suspect's expected destination. Unknowingly, Sergeant McNevin and Tarvis Wilson were running directly at each other.

Sergeant McNevin ran into the suspect in the carport of the suspect's mother's home where he attempted to place the suspect into custody. Wilson broke Sergeant McNevin's grip and continued to flee with Sergeant McNevin close behind. In an instant, Wilson pulled his gun, turned, and fired at Sergeant McNevin. The shot was a near fatal hit striking Sergeant McNevin in the lower

abdomen but stopped by his bullet resistant vest. Stunned by the impact, he fell to his hands and knees. Wilson seized the opportunity and fired two more rounds barely missing the officer.

At that moment Officer Medeiros appeared. Seeing how vulnerable Sergeant McNevin was, Officer Medeiros immediately placed his body between the injured officer and the suspect. Officer Medeiros and Wilson continued to exchange shots as Officer Medeiros shielded Sergeant McNevin and Wilson fled. Wilson continued to flee officers until he was ultimately shot and apprehended. As soon as he realized that Wilson was no longer a threat, Officer Medeiros began administering first aid to Sergeant McNevin. He continued to reassure him that he would be all right and stayed with his colleague until paramedics arrived.

In a letter supporting Officer Medeiros' nomination for the Officer of the Month award, Sergeant McNevin wrote, "In all likelihood, Officer Matthew Medeiros saved my life that day. In complete disregard for his own personal safety, he placed himself directly in the line of fire. He acted with courage, bravery and honor."

On May 9th, 2009, the Boynton Beach Police Department held its 31st Annual Police Memorial Ceremony to honor

fallen officers and recognize those officers who went above and beyond the call of duty. For the first time since the inception of the Department's Award Program, Officer Medeiros was awarded the Boynton Police Department Medal of Valor.

In addition to his Medal of Valor, Officer Medeiros was awarded the Combat Cross in December 2008 and the Officer of the Month Award for August 2008. Officer

Medeiros is the first officer from the Boynton Beach Police Department to be awarded the NLEOMF's Officer of the Month Award.

Located in the nation's capital, the NLEOMF is a nonprofit organization dedicated to honoring the service and sacrifice of America's law enforcement officers. The NLEOMF Officer of the Month Program began in September 1996 and recognizes federal, state and local officers who distinguish themselves through exemplary law enforcement service and devotion to duty.

Officer Medeiros, along with the other Officers of the Month for 2010, will be honored at a special awards luncheon in Washington, DC, in May 2011 during National Police Week. In addition, their stories of heroism and service will be featured in the Memorial Fund's 2012 calendar.

REMINDER

The legal defense policies of the Florida and Palm Beach County PBA have an important provision regarding representation. If a member elects to secure representation by anyone other than the PBA (a private attorney, for example) that member is considered to have waived representation by the PBA. Once this happens, it is the PBA's option whether or not to continue to represent the member in that matter. Please call the PBA office if you have any questions regarding this policy.

ATTENTION: RETIREES

Please take notice that pursuant to §95.11(3), Florida Statutes, lawsuits, including "an action founded on negligence," and "for assault, battery, false arrest, false imprisonment, or any other intentional tort..." must be filed "WITHIN FOUR YEARS" of the incident date.

To the extent that such lawsuits may be brought against you <u>after</u> you retire, you need to consider continuing your membership for four (4) years beyond your retirement.

If you are retired but have returned to law enforcement and are currently paying a "RETIREE MEMBER-SHIP," you should be aware that if you are subject to such actions at a time when you no longer are paying the appropriate dues, the PBA cannot provide legal assistance. See Palm Beach County Policy 12-1.

Enjoy the full peace of mind your retirement should mean.

Know Your Rights!

If you are under investigation, remember, as a law enforcement officer, you have rights. They include:

THE RIGHT . . . to have a PBA representative present during an interview

 $\ensuremath{\mathbf{THE}}\ \mathbf{RIGHT}$. . . to know who's in charge of the investigation

THE RIGHT . . . to know what the charges are and the name of the person bringing the charges

 $\ensuremath{\mathbf{THE\;RIGHT}}$. . . to have the interview at a reasonable time and for a reasonable length of time

THE RIGHT . . . to have any interview tape-recorded from start to finish

THE RIGHT . . . not to be threatened, bribed or to have to listen to offensive language

THE RIGHT . . . not to be forced to resign

817.311 UNLAWFUL USE OF BADGES, ETC.

(1) (817.311 SS)From and after May 9, 1949, any person who shall wear or display a badge, button, insignia or other emblem, or shall use the name of or claim to be a member of any benevolent, fraternal, social, humane, or charitable organization, which organization is entitled to the exclusive use of such name and such badge, button, insignia or emblem either in the identical form or in such near resemblance thereto as to be a colorable imitation thereof, unless such person is entitled so to do under the laws, rules and regulations of such organization, shall be guilty of a misdemeanor of the first degree, punishable as provided in S. 775.082 or S. 775.083.

(2) This section shall be cumulative to any and all laws now in force in the state.

Florida Statutes (1987).

PLEASE NOTE

843.085 Unlawful Use of police badges or other indicia of authority: (l) Unless appointed by the Governor pursuant to chapter 354, authorized by the appropriate agency, or displayed in a closed or mounted case as a collection or exhibit, to wear or display any authorized indicia of authority, including any badge, insignia, emblem, identification card, or uniform, or any colorable imitation thereof, of any federal, state, county, or municipal law enforcement agency, or other criminal justice agency as now or hereafter defined in S. 943.045, which could deceive a reasonable person into believing that such item is authorized by any of the agencies described above for use by the person displaying or wearing it, or which displays in any manner or combination the word or words "police," "patrolman," "agent," "sheriff," "deputy," "trooper," "highway patrol," "Wildlife Officer," "Marine Patrol Officer," "state attorney," "public defender," "marshal," "constable," or "bailiff," which could deceive a reasonable person into believing that such item is authorized by any of the agencies described above for use by the person displaying or wearing it.

(2) To own or operate a motor vehicle marked or identified in any manner or combination by the word or words "police," (etc.) Or by any lettering, marking, or insignia, or colorable imitation thereof, including but not limited to, stars, badges, or shields, officially used to identify the vehicle as a federal, state, county or municipal law enforcement vehicle or a vehicle used by a criminal justice agency as now or hereafter defined in s. 943.045, which could deceive a reasonable person into believing that such vehicle is authorized by any of the agencies described above for use by the person operating the motor vehicle, unless such vehicle is owned or operated by the appropriate agency and its use is authorized by such agency, or the local law enforcement agency authorizes the use of such vehicle or unless the person is appointed by the Governor pursuant to chapter

(3) To sell, transfer, or give away the authorized badge or colorable imitation thereof, including miniatures of any . . .

(4) NOTHING IN THIS SECTION SHALL PROHIBIT A FRATERNAL, BENEVOLENT, OR LABOR ORGANIZATION OR ASSOCIATION, OR THEIR CHAPTERS OR SUBSIDIARIES, FROM USING THE FOLLOWING WORDS, IN ANY MANNER OR IN ANY COMBINATION, IF THOSE WORDS APPEAR IN THE OFFICIAL NAME OF THE ORGANIZATIONS OR ASSOCIATIONS.

What's Really Causing My Headaches?

f you are one of the many people who suffer from headaches on a regular basis, you should know that there is a solution and it definitely is not normal to have daily or even weekly headaches. There are different causes of headaches, but they all boil down to one common denominator,

and that is stress. Stress comes in a variety of forms, from mental and chemical stress to physical stress. Let's discuss how to determine the cause of your headaches and some possible solutions.

Mental and emotional stress is an obvious cause of headaches. If you know that you are under a lot of stress at home and work, find time on a daily basis to do deep breathing exercises. This brings oxygen to the brain and helps relax the muscles. When under stress, we may clench our teeth and tighten our muscles without realizing it, so deep breathing exercises throughout the day helps counteract this effect. Regular exercise helps relieve stress, so a morning stretch to get the blood flowing to the brain is helpful, and if you can squeeze in a cardio routine of 20-30 minutes in the morning, even better.

Chemical stress is a possible cause of headaches which may be the most overlooked. Things we are exposed to or ingest can cause headaches. Be aware of certain fumes or cleaning products you come in contact with on a daily basis. Certain foods and byproducts can cause headaches. Acidic foods in excess, like tomatoes, MSG, and caffeine. People trying to cut back to a more acceptable 1-2 cups of coffee or soda a day should do so gradually to avoid those bad caffeine withdrawal headaches. And let's not forget some medication can have headaches as a side effect, as well as some oral contraceptives.

Physical stress is often overlooked as a cause of headaches. Obviously if you hit your head, that can cause a headache, but if that headache lasts more than a day, you need to have that bump checked out further. If you over exert yourself, especially on a sunny day, you can cause a headache, so protect your eyes with sunglasses and a hat if necessary and drink plenty of water. This helps hydrate the body and prevent a headache. Headaches can be organic in nature and caused by tumors

What if you've explored all these options and none seem to be the cause of your headache? Stress in your neck due to pinched nerves can cause headaches. If you get a chiropractic exam including x-rays that show misaligned bones in your neck, there's a good chance that this is the cause of headaches. So if you've explored all other options and still suffer from headaches, make sure you visit your chiropractor for an evaluation.


